

Pursuant to the order passed by this Court, the Deputy

Commissioner, Kinnaur District at Reckong Peo has filed his affidavit

dated 18.4.2022, wherein in paragraph 2, he has stated as follows :-

"That, in compliance to the directions passed by the Hon'ble High Court on 22.3.2022, the deponent inspected the site on 26.3.2022 and it has found that project proponent had been dumping muck/debris on designated dumping site No.3 bearing khasra No. 724/576/1, 571/1 measuring 0-89-28 hect. Situated at up mohal Rang, which has already been diverted in favour of Shongtong Karchham HEP by Ministry of Environment and Forest on 14.11.2012 and also found that neither any tree is being damaged or cut nor any debris is being thrown in the Satluj river and there is no interference with the course of river Satluj. Suitable land for muck dumping is very scarce in the District, that is why the dumping yard cannot be re-located and most of the area of District Kinnaur is Forest Area."



Learned counsel for the petitioner states that the petitioner can suggest some alternate sites where the dumping yard can be re-allocated. We permit the petitioner to submit a plan showing the alternate sites where the muck/debris can be re-located.
